## Youth Empowerment and Social Transformation

### Call for Participants

#### General Information

EU countries and its Eastern partners are being challenged by cuts of individual and collective rights in the last years, and by an uprising of ultra-nationalist and anti-EU social and political movements that represent a threat for the maintenance of these rights and the amend of those that have been already set aside. The cuts on the rights and the populist ultra-nationalist uprising differ on its intensity depending on the country and regions, but are happening nowadays at an increasing speed within the EU.

Youth and youth CSOs can contribute to trigger positive changes through social, economic, legal and cultural movements, and therefore reinforce the structures that guarantee the observation of basic rights for citizens in Europe. Youth organizations, though, are often lacking long-term strategies, international perspectives, are easy to manipulate and have a poor understanding of the processes of social transformation and the role they play on them.

Against this background, the project proposal aims **to empower youth CSOs by strengthening their understanding of processes of social transformation and increasing their competences on developing initiatives that include strategic planning and social transformative approaches**. Therefore, 24 youth workers from Germany, Poland, Spain, The United Kingdom, Belarus, Ukraine, Armenia and Georgia will participate in the project.

The **objectives** of the project are:

- To strengthen the understanding of youth empowerment as a tool for social transformation in youth CSOs
- To increase the use of systematic and long-term approaches to social transformation in youth CSOs
- To exchange good practices for youth empowerment work and social transformation among the participating organizations
- To establish transnational links between CSOs in the youth sector and translate them into project-based partnership for needs-based social transformation

The project will include **two e-learning modules, two residential training courses, and follow-up events**.

#### Activity details and timeline:

1st e-learning module (4 weeks, online, February/ March 2017):

- Exploring concepts and theories for youth empowerment
- Exploring concepts and theories for social transformation
- Discussing the main elements of these concepts among the participants
- Identifying local examples and initiatives using these approaches in the countries represented

1st Training Course (Misaksieli, Georgia. 27 March to 04 April 2017):

- Deepen into the concepts and theories of youth empowerment and social transformation
- Deepen into the logics of theoretical frameworks and how this affects the work of the CSOs represented (value-based frameworks)
- Provide participants with tools for community-based needs assessment
- Serve as a platform to discover challenges and initiatives in different countries

2nd e-learning module (4 weeks, online, May/ June 2017):

- Provide with tools for analysis of community based problems
- Support the usage of analytical tools to process the results of the community-based needs assessment
- Provide participants with space to share and follow the work of the other groups, and go through a peer-to-peer learning and multiplicative process

- Introduce the basic theories of Theory of Change and Logical Framework.

2nd Training Course (Kobuleti, Georgia. 12 to 20 of June 2017):

- Deepening into the conceptual understanding of theory of change and logical framework for social transformation
- Developing strategic value-based theories of change for social transformation addressing the needs identified during the e-learning modules and using the intervention points defined
- Planning follow-up activities in cooperation between the organizations

Follow-up events (July-September 2017):

All national groups are required to organise a small scale local event in their communities. These events can take the following shape:

- Informational event about the project
- Educational event about social transformation
- Discussion/ debate about social change and youth work
- Any other event organised by the participants related to the topic of youth empowerment and social transformation

**Important: The participants have to participate in the entire educational programme.**

## Participant Profile

---

**The participants are obliged to follow the whole project, meaning that the two e-learning phases and both training courses are obligatory for all participants.**

The requested profile of participants is the following:

- Working and/or being actively involved in the daily work of the partner organization and able to apply immediately the acquired competences of the training courses and the follow-up activities
- Basic knowledge of the role of youth work in processes of social transformation
- Basic knowledge of the situation of young people in the own country and/or community
- Experience working with young people, preferably with young people with fewer opportunities)
- Work experience as a coordinator and/or leader in a youth CSO
- Involved in management and planning processes within a CSO, a social initiative or a youth movement
- Motivation to take part in a mutual learning process in a very intercultural setting
- Good level of English to follow the course and to contribute to it
- Readiness to attend the full educational programme (two e-learning modules and two training courses)

## Practical Information – 1<sup>st</sup> Residential Training Course

**Arrival day:** 27 March 2017

**Departure day:** 04 April 2017

The travel dates are: 27 March 2017 for arrival at the venue and 04 April 2017 for departure from the venue. You are allowed to stay up to 3 days extra outside these dates. Outside this time frame, your travel costs will **NOT** be reimbursed.

**You are requested to arrive on the 27<sup>th</sup> of March 2017 not later than 5pm local time at the project venue.**

### Accommodation and Food

### Travelling to Georgia

---

Participants should travel by plane to Tbilisi or Kutaisi, except if coming from the neighbouring country Armenia. The cheapest flight connections to Tbilisi are via Riga (Air Baltic), Istanbul (Turkish Airlines and Pegasus Airlines), Kiev (Ukrainian airlines). Travelling to Kutaisi is possible with Ukrainian Airlines (from Kiev) and with Wizzair (from various locations e.g. Poland, Lithuania, Bulgaria, Germany). Connections through Munich or Frankfurt (Lufthansa) also exist, but are usually more expensive.

Participants from Armenia are requested to travel by land (train, bus, mini-bus).

The participants will be transferred from Tbilisi city to the venue by mini-bus. The pick-up schedule to Misaktsieli will be communicated to all participants once all tickets are booked. The transfer will be organised on March 27 2017. No arrivals to the hotel before March 27 midday is foreseen.

*! Please note that participants are in charge of covering 25% of their travel costs to the venue, thus if the organisers organise pre-paid mini-bus from Tbilisi Airport/ Tbilisi to Misaktsieli, we will deduct the 25% of this cost from your travel reimbursements!*

*!! Please note that the organisers do not organise any transfers to Misaktsieli outside the indicated dates. As well the organisers will not cover any accommodation and food costs outside the project dates (27 March 2016 – 04 April 2016 // First meal: dinner on March 27, last meal: breakfast on April 04).*

## Financial Conditions/ Reimbursements

---

The course is implemented in the frame of the Erasmus+ Programme. Accommodation, food and activities are fully covered by the organisers.

**75% of the travel costs to the venue and back will be reimbursed up to the maximum of the amount indicated above. Please consult the travel budget list above!**

As the reimbursement amount depends on the travel distance between the place of departure and the project venue the following additional regulation applies: if the departure place of the participants differ from the seat of the organisation on which the travel budget below is based, and if this causes that the travel distance falls into a lower distance band, then the travel budget for the lower distance band applies.

Reimbursement will only be done for travel costs (cheapest mean of transportation, only economy class, no taxi) upon presentation of original tickets, invoices (and boarding tags for flight tickets).

The travel dates are: 27 March 2017 for arrival at the venue and 04 April 2017 for departure from the venue. You are allowed to stay up to 3 days extra outside these dates. Outside this time frame, your travel costs will **NOT** be reimbursed.

Participants from Armenia, Georgia, Belarus and Ukraine will receive the reimbursements **in EURO in cash** on spot in Georgia upon presentation of booked return travel documents and boarding tags. Please book your return tickets before departure, so that we can reimburse you. No reimbursement will be calculated based on non-booked tickets or estimations!

Participants from EU countries will receive the reimbursements via **bank transfer** after the course upon reception of the return travel documents and international bank details. No exception to this rule will be done. Post address where to send the documents will be handed out to the participants during the course.

Please have in mind that the transport Tbilisi - Misaktsieli – Tbilisi will be organised by the organisers and that you have to cover 25% of these costs. The corresponding amount will be deducted from your final reimbursement. The costs will be around 10 EUR, which is approximately 3 EUR for the 25% per person.

**!! Bring the original invoices and tickets, print out e-tickets and keep your boarding passes. On all documents the price, currency, name of passenger, date of purchase and travel should be clearly visible, otherwise we will not be able to reimburse the travel costs. Please make an extra copy of all your documents to hand out to the organisers!**

!! Reimbursement will be done in EUR, regardless of the currency indicated on the ticket and receipt/ invoice. Any tickets purchased in a currency other than EUR, will be converted and calculated according to the exchange rate of the month when the ticket/s were purchased.
